

Therefore, His Excellency the Governor General in Council, on the recommendation of the Minister of Justice and the Treasury Board, pursuant to paragraphs 117(p) and (q) of An Act respecting firearms and other weapons<sup>a</sup>, hereby makes the annexed *Firearms Fees Regulations*.

## FIREARMS FEES REGULATIONS

### INTERPRETATION

1. The definitions in this section apply in these Regulations.

"Act" means the *Firearms Act*. (*Loi*)

"non-restricted firearm" means a firearm other than a prohibited firearm or a restricted firearm. (*arme à feu sans restrictions*)

### PART I

#### INDIVIDUALS

##### *Fees Payable for Licences*

2. Subject to the waivers and reductions set out in sections 3 to 8, the fee payable by an individual for a licence described in column I of an item of Schedule I is the appropriate fee set out in column II of that item, determined according to the period in which the application for the licence is made.

##### *Waiver and Reduction of Fees*

3. Where an individual <sup>at least for 1 year</sup> holds a licence described in column I of item 1 of Schedule I and within 3 years of the date of issuance of that licence makes an application for a licence described in column I of item 4 of that Schedule, the fee payable for the licence is reduced by 50 per cent.

4. Where an individual <sup>has held a</sup> holds a licence described in column I of paragraph 4(a) of Schedule I and makes an application for a licence described in column I of paragraph 4(b) or (c) of that Schedule, the fee payable for that licence is <sup>for at least 1 year</sup> \$20 <sup>reduced by 50 per cent</sup>.

5. Where an individual holds a firearm acquisition certificate issued under the former Act and makes an application for a licence described in column I of item 4 of Schedule 1 on or after January 1, 2001, the fee payable for that licence is reduced by <sup>within 3 years of the date of issuance of that licence</sup>

(a) \$10 if the firearm acquisition certificate expires in the period between January 1, 2001 and December 31, 2001; and

(b) \$20 if the firearm acquisition certificate expires in the period between January 1, 2002 and December 31, 2002.

6. The fee payable for a licence described in column I of item 2 of Schedule I is waived for an individual who is eligible to hold the licence under subsection 8(2) of the Act.

7. The fee payable for a licence described in column I of paragraph 1(a) or 4(a) of Schedule I is waived for any person referred to in section 3 of the *Aboriginal Peoples of Canada Adaptations Regulations (Firearms)*.

8. The fee payable for a licence described in column I of paragraph 1(a) or 4(a) of Schedule I is waived for individuals who require firearms to hunt or trap in order to sustain themselves or their families.

## PART II

### BUSINESSES

#### *Fees Payable for Licences*

9. (1) Subject to subsection (2), the fee payable by a business for a licence to carry on an activity described in column I of an item of Part I of Schedule II is the appropriate fee set out in column II of that item, determined according to the period in which the application for the licence is made.

(2) Where there are two or more activities described in column I of an item of Part I of Schedule II that are carried on by a business in the same place, the fee payable by the business for a licence to carry on those activities is the greatest of the appropriate fees set out in column II of that item, determined according to the period in which the application for the licence is made.

(3) For the purposes of paragraphs 1(a) to (d) of Part I of Schedule II, the number of retail sales of firearms made by a business is the number of those sales made by that business in the 12 month period before the day on which the application for the licence to carry on the activities is made.

(4) For the purposes of items 7 and 8 of Part I of Schedule II, the number of firearms possessed by a museum is the <sup>maximum</sup> number of firearms possessed by that museum in the 12 month period before the day on which the application for the licence to carry on the activities is made. <sub>at any time</sub>

## PART III

### REGISTRATION CERTIFICATES, AUTHORIZATIONS AND CONFIRMATIONS

- 3 -

### *Fees Payable for Registration Certificates*

10. (1) The fee payable by an individual for a registration certificate for a firearm referred to in column I of item 1 or 2 of Part I of Schedule III that is acquired or transferred on or after the commencement day is the appropriate fee set out in column II of that item, determined according to the period in which the application is made.

(2) The fee payable by an individual for a registration certificate for a firearm referred to in column I of item 3 of Part I of Schedule III that is acquired or transferred after January 1, 1998 or such other date as is prescribed pursuant to subsection 98(3) of the *Criminal Code*, whichever date is later, is the appropriate fee set out in column II of that item, determined according to the period in which the application is made.

(3) Where an individual possesses firearms referred to in column I of item 4 of Part II of Schedule III on January 1, 1998 or such other date as is prescribed pursuant to subsection 98(3) of the *Criminal Code*, whichever date is later, and makes an application for a registration certificate for one or more of those firearms, the fee payable for all the registration certificates, regardless of the number of registration certificates requested in that application, is the appropriate fee set out in column II of that item, determined according to the period in which the application is made.

### *Waiver of Fees*

11. The fee payable for a registration certificate for restricted firearms or prohibited firearms is waived where, on the commencement day, those firearms were registered as restricted weapons under the former Act.

12. The fee payable under subsection 10(3) is waived for any person referred to in section 3 of the *Aboriginal Peoples of Canada Adaptations Regulations (Firearms)*.

13. The fee payable under subsection 10(3) is waived for individuals who require firearms to hunt or trap in order to sustain themselves or their families.

### *Fees Payable for Authorizations and Confirmations*

14. Subject to sections 15 to 17, the fee payable for a document described in column I of an item of Schedule IV is the fee set out in column II of that item.

### *Waivers and Reduction of Fees*

- 4 -

15. Where the applicant so elects, the fee payable for an authorization described in column I of item 1 of Schedule IV is as follows:

(a) \$5,000 for the first application, in which case the fees payable for the next 299 authorizations of the same type that are applied for in the 12 month period following the date of the first application are waived;

(b) \$2,000 for the 301st application, in which case the fee payable for the next 199 authorizations of the same type that are applied for in the 12 month period following the date of the 301st application are waived; and

(c) \$2,000 for the 501st application, in which case the fee payable for the next 199 authorizations of the same type that are applied for in the 12 month period following the date of the 501st application are waived.

16. Where the applicant so elects, the fee payable for an authorization described in column I of item 2 of Schedule IV is as follows:

(a) \$5,000 for the first application, in which case the fees payable for the next 299 authorizations of the same type that are applied for in the 12 month period following the date of the first application are waived;

(b) \$2,000 for the 301st application, in which case the fee payable for the next 199 authorizations of the same type that are applied for in the 12 month period following the date of the 301st application are waived; and

(c) \$2,000 for the 501st application, in which case the fee payable for the next 199 authorizations of the same type that are applied for in the 12 month period following the date of the 501st application are waived.

17. Where an applicant has not made an election under section 15 or 16 and makes an application by way of **electronic transfer**, the fee payable described in item 1(b) or 2(b) is reduced by 50 per cent. \*?

18. The fee payable for an authorization described in column I of item 5 or 6 of Schedule IV is waived for an individual referred to in section 18 or subsection 19(1) of the Act where that individual changes residence.

## FIREARMS FEES REGULATIONS

### INTERPRETATION

1. The definitions in this section apply in these Regulations.

"Act" means the *Firearms Act*. (*Loi*)

"non-restricted firearm" means a firearm other than a prohibited firearm or a restricted firearm. (*arme à feu sans restrictions*)

### PART I

## FIREARMS FEES REGULATIONS

### INTERPRETATION

1. The definitions in this section apply in these Regulations.

"Act" means the *Firearms Act*. (*Loi*)

"non-restricted firearm" means a firearm other than a prohibited firearm or a restricted firearm. (*arme à feu sans restrictions*)

### PART I

#### INDIVIDUALS

##### *Fees Payable for Licences*

2. Subject to the waivers and reductions set out in sections 3 to 7, the fee payable by an individual for a licence described in column I of an item of Schedule I is the appropriate fee set out in column II of that item, determined according to the period in which the application for the licence is made.

##### *Waiver and Reduction of Fees*

3. Where an individual holds a licence described in column I of item 1 of Schedule I and makes an application for a licence described in column I of item 4 of that Schedule, the fee payable for that licence is waived or reduced as follows:

(a) the fee payable is \$50, if the application is made during the period beginning on April 1, 1997 and ending on December 31, 1997;

(b) the fee payable is \$15, if the application is made during the period beginning on January 1, 1998 and ending on December 31, 1998; and

(c) the fee payable is waived if the application is made after December 31, 1998.

4. Where an individual holds a licence described in column I of paragraph 4(a) of Schedule I and makes an application for a licence described in column I of paragraph 4(b) or (c) of that Schedule, the fee payable for that licence is \$20.

5. The fee payable for a licence described in column I of item 2 of Schedule I is waived for an individual who is eligible to hold the licence under subsection 8(2) of the Act.

6. The fee payable for a licence described in column I of paragraph 1(a) or 4(a) of Schedule I is waived for Aboriginal peoples of Canada.

7. The fee payable for a licence described in column I of paragraph 1(a) or 4(a) of Schedule I is waived for individuals who require firearms to hunt or trap in order to sustain themselves or their families.

8. Where an individual holds or has held a licence described in column I of item 3 of Schedule I and makes an application for another licence described in that item within one year after the date of issuance of the first licence, the fee payable for that licence is \$30.

##### *Waiver of Fees*

11. The fee payable for a registration certificate for restricted firearms or prohibited firearms is waived where, on the commencement day, those firearms were registered as restricted weapons under the former Act.

12. The fee payable for a registration certificate for a frame or receiver of a firearm by a business that manufactures firearms is waived.

##### *Fees Payable for Authorizations*

13. (1) Subject to section 14, the fee payable for an authorization described in column I of an item of Schedule IV is the fee set out in column II of that item.

(2) The fee payable for an amendment to an authorization described in column I of an item of Schedule IV is \$10, where the amendment was requested before January 1, 2002, and \$15 where it was requested on or after that date.

#### *Waivers and Reduction of Fees*

14. Where the applicant so elects, the fee payable for an authorization described in column <sup>(1)</sup> of item 1 or 2 of Schedule IV is as follows:

(a) \$150 for the first application, in which case the fees payable for the next nine authorizations of the same type that are applied for in the twelve month period following the first application are waived; and

(b) \$7.50 for each additional authorization of the type referred to in paragraph (a) that are applied for in the twelve month period following the first application.

#### PART IV

#### GENERAL

#### *Replacement*

15. (1) Subject to subsection (2), the fee payable for the replacement of any document described in column I of an item of Schedule V is the appropriate fee set out in column II of that item, determined according to the period in which the request for the replacement is made.

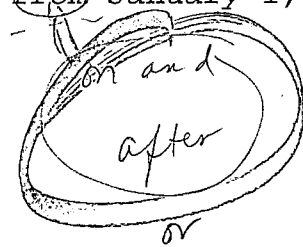

2. For the purposes of paragraph 44(b) of the Act, any of the purposes described in section 21 of the *Firearms Licences Regulations* is a prescribed purpose for the exportation of goods described in that paragraph.

*Information to be Provided to the Registrar*

3. (1) For the purposes of paragraph 44(e) of the Act, a business that applies for an authorization to export goods described in section 43 of the Act shall provide the Registrar with the following information:

(a) the quantity of each type of goods;

(b) a description of the goods that is sufficiently detailed to permit them to be identified in accordance with any definitions set out in section 84 of the *Criminal Code* that are applicable;

(c) if known, the name of the country that is the final destination of the goods and the name of any country in which the goods stop over;

(d) the name and address of the consignee of the goods;

(e) the name and address of the business that is making the application for an authorization to export the goods;

(f) the number and expiration date of the licence referred to in paragraph 44(c) of the Act;

(g) where applicable, the permit number and the expiration date of the export permit issued to the business pursuant to the *Export and Import Permits Act*;

(h) the proposed date of export of the goods;

(j) the name and licence number of the carrier; and

(k) whether the goods will be imported back to Canada.

(2) Where the application is in respect of a firearm, the following information shall be provided in addition to the information referred to in subsection (1):

(a) if known, the make, model, type, action, calibre and barrel length of the firearm; and

(b) subject to subsection (3), the serial number or, where no serial number exists, the firearms identification number assigned by the Registrar at the time of registration.

(3) Where a serial number for a firearm exists but is not available at the time the application is made, the business may make the application without providing the serial number and the Registrar shall attach to an authorization issued in respect of that firearm the condition that the business provide the serial number to the Registrar before the export of the firearm.

#### *Mandatory Conditions*

4. Where a business applies for an authorization to export goods described in section 43 of the Act, the Registrar shall attach to an authorization issued in respect of those goods the condition that the goods be identified by marking the quantity of each type of goods and the following information in a machine-readable form on the outer packaging of the goods:

(a) in the case of firearms,

(i) a description that is sufficiently detailed to permit the firearms to be identified in accordance with the definitions set out in section 84 of the *Criminal Code*,

(b) give the goods to the Royal Canadian Mounted Police or the chief firearms officer of the province in which the goods are detained for the use of the Royal Canadian Mounted Police or the chief firearms officer or for any other legitimate purpose other than sale; or

(c) have the goods destroyed.

(2) Before disposing of goods, a customs officer shall advise the Registrar of the goods that were detained and the manner in which those goods are to be disposed.

## PART II

### AUTHORIZATION TO IMPORT

#### *Purposes of Importation for Prohibited Goods*

6. For the purposes of paragraph 46(d) of the Act, any of the purposes described in section 21 of the *Firearms Licences Regulations* is a prescribed purpose for the importation of goods described in that paragraph.

#### *Information Provided to the Registrar*

7. (1) For the purposes of paragraph 46(f) of the Act, a business that applies for an authorization to import goods described in section 43 of the Act shall provide the Registrar with the following information:

- (j) the name and licence number of the carrier.

(2) Where the application is in respect of a firearm, the following information shall be provided in addition to the information referred to in subsection (1):

- (a) if known, the make, model, type, action, calibre and barrel length of the firearm; and
- (b) subject to subsection (3), the serial number or, where no serial number exists, the firearms identification number assigned by the Registrar at the time of registration.

(3) Where a serial number for a firearm exists but is not available at the time the application is made, the business may make the application without providing the serial number and the Registrar shall attach to an authorization issued in respect of that firearm the condition that the business provide the serial number to the Registrar before the import of the firearm.

#### *Mandatory Conditions*

8. Where a business applies for an authorization to import goods described in section 43 of the Act, the Registrar shall attach to an authorization issued in respect of those goods the

(2) Before disposing of goods, a customs officer shall advise the Registrar of the goods that were forfeited and the manner in which those goods are to be disposed.

### PART III

#### GENERAL

#### *Notice of Refusal or Revocation*

10. (1) A notice of a decision to refuse to issue an authorization to export or import goods or to revoke such an authorization is sufficiently given if the notice is addressed to the last known address of the business that applied for or is the holder of the authorization and the notice is, as the case may be,

(a) on the day of delivery, if it is delivered personally;

#### *Revocation of Authorizations*

11. The Registrar may revoke an authorization for the export or import of goods at any time before the authorization is confirmed by a customs officer pursuant to subsection 45(2) or 47(2) of the Act.

12. The Registrar shall revoke an authorization, issued to a business, for the export or import of goods before the goods are exported or imported, as the case may be, if the Registrar has reason to believe that the licences referred to in paragraphs 3(1)(f) and 7(1)(g) or the permit referred to in paragraph 3(1)(g) are no longer valid.

#### *Notice of Refusal to Confirm Authorization*

13. Where a customs officer refuses to confirm an authorization to export or import under subsections 45(2) or 47(2) of the Act, the customs officer shall notify, in writing, the business and the Registrar of the reasons for the refusal and, where the goods are detained under subsection 45(3) of the Act, the reasons for detaining the goods.

## **REGULATORY IMPACT ANALYSIS STATEMENT**

### *Description*

These Regulations comprise several components of a comprehensive regulatory package implementing the firearms control legislation enacted by *An Act respecting firearms and other weapons*, S.C. 1995, c. 39, which was assented to on December 5, 1995.

The Regulations support a new statutory scheme for the control of firearms and other weapons, composed of the new *Firearms Act* and a completely amended Part III of the *Criminal Code*. The *Firearms Act* provides for licences, registration certificates and authorizations under which persons may possess firearms and certain other weapons, in

circumstances that would otherwise constitute an offence under Part III of the *Criminal Code*.

The Regulations may not be made until they have been laid before Parliament for review, and the period prescribed in section 118(4) of the *Firearms Act* for review by Parliament has expired. Further regulations are required to support the new scheme of the *Firearms Act* and Part III of the *Criminal Code*, and a second package of proposed regulations will be laid before Parliament for review in the fall of 1996.

#### Firearms Licences Regulations

These Regulations provide for eligibility requirements and procedures for individuals to obtain licences to possess, or to possess and acquire, firearms and other regulated weapons. They deal with licences to possess and acquire firearms, licences authorizing possession only for those who already have firearms when the new scheme comes into force, possession licences for minors, non-residents sixty-day licences to borrow firearms, and licences to acquire cross-bows. Applications for possession only licences will involve a relatively simple process, while additional requirements will apply to other kinds of licences.

The Regulations also provide for licences for businesses to possess and deal in firearms and other regulated weapons. The provisions include such matters as: the eligibility requirements for museums seeking licences to possess firearms; the prescribed purposes for which businesses could be authorized to possess prohibited firearms, weapons, devices or ammunition; the mandatory conditions which will be attached to business licences; and the manner in which notices of refusal or revocation will be given.

#### Storage, Display and Transportation of Firearms and Others Weapons Regulations

The existing regulations dealing with storage, display and transportation of non-restricted, restricted and prohibited firearms by individuals and businesses, now set out separately, will be brought together in these combined Regulations.

The Regulations will set enhanced safety standards for individuals and will require a firearm to be secured by locking devices and securely stored, displayed or transported, when not in use. The proposed Regulations also contain a separate part dealing with the storage, display and transportation of firearms and other weapons by businesses.

#### Authorizations to Transport Restricted Firearms and Prohibited Firearms Regulations

These Regulations provide for the procedural matters regarding the issuance of authorizations to transport restricted or prohibited firearms. They deal with the required contents of the authorizations, mandatory conditions which must be attached, and the circumstances in which revocation is mandatory. They also provide for the manner in which a notice of refusal or revocation must be given.

### Authorizations to Carry Restricted Firearms and Certain Handguns Regulations

These Regulations set out the circumstances in which an individual is deemed to need a handgun or other restricted firearm for the purpose of carrying such a firearm on the person to protect life or for a lawful profession or occupation. They also provide for the procedures for an application, the mandatory conditions which must be attached, the circumstances in which revocation is mandatory, and the manner in which a notice of refusal or revocation must be given.

### Non-Prohibited Ammunition Transfer Document Regulations

These regulations prescribe the alternative document which may be used, in lieu of a licence issued under the *Firearms Act*, during the transition period between the coming into force of the new scheme and January 1, 2001, when all persons in possession of firearms are required to have such a licence. The Regulations require individuals 18 years of age or older to have a document issued by a government or government agency showing the age or date of birth of the holder. The required alternate document for purchase of ammunition by those under the age of 18 will be a minors' permit issued under the current provisions of the *Criminal Code*.

### *Alternatives Considered*

These Regulations are required to support the scheme for control of firearms and other weapons set out in the *Firearms Act*. The Act itself creates a comprehensive system of licensing of persons in possession of firearms and certain other weapons, registration of firearms, and authorizations for transport of certain firearms. Business activities involving firearms and certain other weapons are also controlled by the Act. This statutory framework requires a supporting body of regulations to set out detailed requirements and procedures to implement the provisions of the statute. An exclusively statutory scheme would be impracticable and too inflexible. The Regulations will also be supplemented by forms prescribed by the Minister, and by administrative and advisory materials for use in communications and training programs.

### *Consistency with Regulatory Policy and Citizens' Code*

Notice of the proposed Regulations was given in the 1996 Federal Regulatory Plan, and they are republished in the *Canada Gazette*, Part 1 in accordance with Government regulatory policy.

### *Anticipated Impact*

The proposed Regulations will affect all Canadian residents who possess or seek to acquire a firearm, as well as businesses whose activities involve firearms. The precise number of affected individuals is unknown, but it is estimated to be several million persons. The licensing requirement of the *Firearms Act* will therefore be phased in, and pursuant to the provisions of the Act and the *Criminal Code* those affected will have until January 1, 2001, to obtain the appropriate licence.

### *Small Business Impact*

All firearms businesses will be affected by the proposed Regulations dealing with business licences. While some of the provisions will add additional requirements for these businesses, others will clarify or expand the existing regulatory law in the interests of certain businesses. Automated processes and more uniform standards will seek to minimize the impact of the new law, and could improve the conditions for doing business in many cases. The Regulations dealing with authorizations to carry will affect such businesses as security companies. The activities of businesses such as hunting outfitters will also be affected by the individual licensing requirements. The enhanced safety requirements for storage, display and transportation of firearms would increase the compliance required by firearms businesses.

### *Consultation*

Extensive consultations on the development of the proposed Regulations were undertaken with: provincial authorities, in particular the chief provincial and territorial firearms officers; federal departments involved in the implementation of the new law, in particular the Solicitor General, including the Royal Canadian Mounted Police, Revenue Canada - Customs and Excise, and the Department of Foreign Affairs and International Trade, as well as other interested federal departments; representatives of police agencies; firearms user and industry groups, including the User Group on Firearms established by the Minister of Justice as an advisory body; health and safety groups; and, groups representing women, victims of violence, and others concerned about firearms control. The consultation process is ongoing, and will continue as the regulatory packages are developed and implemented.

### *Compliance Mechanism*

Although some offence provisions relevant to matters involving licences and authorizations are set out in the *Firearms Act* itself, most of the offence provisions which support the Act and the proposed Regulations are contained in the new Part III of the

*Criminal Code.* The combination of the two statutes provides for a comprehensive set of compliance mechanisms.

### *Coming into Force*

Section 118(4) of the *Firearms Act* requires that proposed Regulations be tabled in Parliament at least 30 sitting days before they may be made and brought into force. Additional time is required for the development and parliamentary review of the remaining Regulations necessary for initial implementation, and for systems development, training of enforcement personnel, and communication of the necessary compliance information to firearms owners and businesses affected by the Regulations. The Regulations will therefore be made and brought into force late in 1996 or early in 1997.

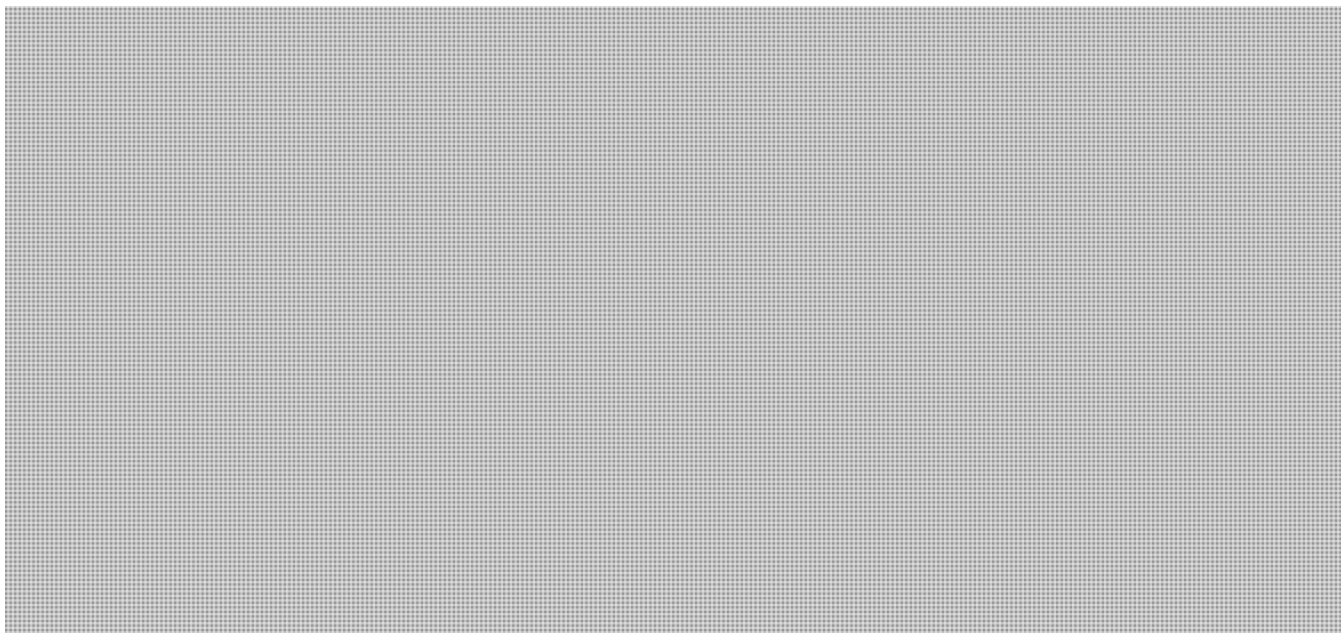

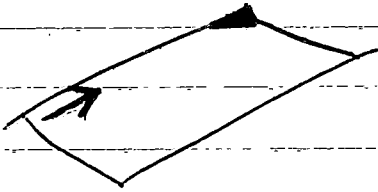

1. Denise, here is my version of s. 2. I'll discuss it briefly with LP tomorrow.

2. I don't agree with adding "Subject to section 7" in s. 5 and 6. I think the fees are payable as stated and that s. 7 will waive the fees. In other words, the fees payable in 5 and 6 are not subject to 7. Does this make sense??

3. I think we have a problem with 8. First of all, where is our authority to make a regulation naming the person to whom the fees are payable. Section 117 (p) only gives us the authority to prescribe fees. We should delete the provision and let the client deal with the matter at an administrative level (See Financial Admin. Act. also. Public Moneys are paid to the Credit of the Receiver General)

Secondly, the client's request to change it to "receiver general" is not right. The Act states indirectly in s. 117(p) that the fees are to be paid to Her Majesty in Right of Canada and so we should not, by Regulation, state the fees are payable to the RG.

## INSTRUCTIONS TO DRAFTERS - FEES REGULATIONS

These instructions are intended to provide a framework for fees regulations made under section 117(p) of the *Firearms Act*. Figures are not yet available, and those figures that are used are intended to be by way of illustration only. In some cases the figure will be shown as "a, b, c" or "x, y, z". The framework will cover all fees for individual licences, but business licence fees will be dealt with in the fall package of proposed regulations. Where fees are to be waived or reduced pursuant to section 117(q) the item will also be left to the fall package. Policy decisions are needed in regard to the manner in which fees for aboriginal peoples will be dealt with, and a definition, involving both policy and legal elements, will be necessary to deal with sustenance hunters.

### INDIVIDUAL LICENCES

#### Definition

"former Act" has the same meaning as in section 2 of the *Firearms Act*

"restricted firearm" has the same meaning as in section 84(1) of the *Criminal Code*

### Part I - Applications for Licences by Individuals 18 Years of Age or Older

#### Section 1

The fee payable on application by an individual, for a licence to possess firearms, shall, subject to section 3, be as set out in Columns I to V (section 3 adds an additional fee for restricted firearms and prohibited handguns, given the additional renewal requirements in section 67(2) of the Act).

Fees will be set for each of the following years - 1997, 1998, 1999, 2000, and renewal (as possession only licences may be applied for only between commencement day and December 31, 2000, all fees thereafter will be for renewals).

Col. I (1997) \$10, x and y for cols. II to III (1998 and 1999), and Cols. IV and V (2000 and renewals) \$60.

**Note to Drafters:** A precedent for a column structure - one which deals with a single fee only - is to be found in the schedule to the Restricted Weapons and Firearms Control Regulations. In this case the columns would be used not to describe different kinds of licences, but to set out the ascending fee scale.

### Section 2(1).

Subject to subsection (2) and section 3, the fee payable by an individual for a licence to possess and acquire firearms and to acquire crossbows (where the application covers both matters, as opposed to an application solely for a licence to acquire crossbows) shall be \$60.

### Section 2(2).

When an applicant for a licence to possess and acquire firearms is certified by a chief firearms officer pursuant to section 7(4)(a) of the *Firearms Act*, there shall be an additional fee of \$z, provided that the additional fee is not payable if the applicant has previously been certified by a firearms officer under section 106(2)(c)(ii) of the former Act.

**Note to Drafters:** The fee would not apply where the person had previously been alternately certified for an FAC and the chief firearms officer's certification for the purposes of a licence under the *Firearms Act* was simply a recognition of that previous alternate certification. It would also not apply where the person had previously been certified by the chief firearms officer pursuant to section 7(4)(a). The fee thus applies only when the alternate certification is carried out pursuant to that application, and the alternate certification then satisfies the safety requirement for any subsequent issuance or renewal, except where the person has been the subject of a prohibition order and must then re-apply and satisfy the safety course or test.

### Section 3.

There shall be an additional fee of \$10 when an individual applies for a licence to possess, or a licence to possess and acquire, a restricted firearm or a handgun referred to in section 12(6) of the *Firearms Act*.

**Note to Drafters:** This additional fee would apply to both issuance of renewal of any licence involving restricted firearms or prohibited handguns. It is intended to cover the additional work involved in recording the purpose for possession on initial issuance and then carrying out the additional investigation required by section 67(2) and (3) of the Act when the licence is renewed.

### Section 4.

The fee payable by an individual for a licence to acquire crossbows shall be (could be less than the fee for a licence to possess and acquire firearms, including the authority to acquire crossbows) \$x.

#### **Section 5.**

The fee payable by an individual for the replacement of a licence referred to in sections 1, 2 and 4 shall be \$y.

**NOTE:** Fees for sustenance hunters will be waived, regardless of whether they are aboriginals or non-aboriginals, for licences to possess only or to possess and acquire firearms that are neither prohibited nor restricted, but this requires a definition which will follow in the fall package of regulations. The replacement fee will probably also be waived.

### **Part II - Minors Licences**

#### **Section 6.**

When an individual who is less than eighteen years of age applies for a licence referred to in section 8(2) of the Act there shall be no fee.

#### **Section 7.**

When an individual who is less than eighteen years of age applies for a licence referred to in section 8(3) of the Act the fee shall be \$a per year for each year or part thereof for which the licence is issued.

#### **Section 8.**

When an individual who is less than eighteen years of age applies for a replacement for a licence referred to in section 7 the fee shall be \$b.

**Note to Drafters:** See the following policy query regarding the fee issues that will be dealt with in the Fall package.



## ADDITIONAL POLICY QUERIES

Section 117(p) also allows for fees to be set for approvals of transfers. I am presuming that we will be dealing with this in the fall, if at all. It also provides for fees for approving importation, but not for approving exportation, but as the fee-setting power for "authorizations" to import and export is a separate item, I am not sure what approvals for importation might involve. There is also authority to set fees for confirmations by customs officers, which I presume we will be adding later.

It has been decided to leave all other fee prescriptions to the fall package as well, including registration certificates, business licences, and authorizations to transport or carry. Of these only the fee for registration certificates might be a problem in terms of the objectives for spring tabling. Certain announcements have been made concerning the cost of registering non-restricted firearms - \$10 for ten guns, etc. However, registration for individuals will not begin until 1999. While the fees for this later phase of the registration process might be available for inclusion in the spring package, we do not yet know what the cost factors might be for registering restricted and prohibited firearms between commencement day and the point at which these registrations are integrated into the CFRS. While firearms owners may thus be anxious to know what the fees for registering non-restricted firearms would be, it would not seem advisable to provide only a partial provision regarding these firearms only prior to settling all of the issues regarding fees for registration. Does this issue need further examination?



## FIREARMS LICENCING FEES (INDIVIDUALS) REGULATIONS

### INTERPRETATION

1. The definition in this section applies in these Regulations.

"Act" means the *Firearms Act*. (*Loi*)

### LICENCE TO POSSESS AND ACQUIRE FIREARMS

2. (1) Subject to subsections (2) and (3), the fee payable by an individual who is 18 years old or older for a licence to possess and acquire firearms is as follows:

- (a) \$\_\_ where the licence applies only to firearms that are neither prohibited firearms nor restricted firearms; and
- (b) \$\_\_ where the licence applies to restricted firearms or prohibited firearms.

(2) Where the individual has a licence to possess firearms at the time of application for a licence referred to in subsection (1), the fee payable is as follows:

- (a) \$\_\_ for a licence applied for in 1997;
- (b) \$\_\_ for a licence applied for in 1998;
- (c) \$\_\_ for a licence applied for in 1999; and
- (d) \$\_\_ for a licence applied for in or after 2000.

(3) Where the individual has a licence referred to in paragraph (1)(a) at the time of application for a licence referred to in paragraph (1)(b), the fee payable is \$\_\_.

### LICENCE TO ACQUIRE CROSS-BOWS

3. The fee payable by an individual who is 18 years old or older for a licence to acquire cross-bows is \$\_\_.

### LICENCE TO POSSESS FIREARMS

4. (1) The fee payable by an individual who is 18 years old or older for a licence to possess firearms where the licence applies only to firearms that are neither prohibited firearms nor restricted firearms is as follows:

- (a) \$\_\_ for a licence applied for in 1997;

- (b) \$\_\_ for a licence applied for in 1998;
- (c) \$\_\_ for a licence applied for in 1999; and
- (d) \$\_\_ for a licence applied for in or after 2000.

(2) The fee payable by an individual who is 18 years old or older for a licence to possess firearms that are restricted firearms or prohibited firearms is as follows:

- (a) \$\_\_ for a licence applied for in 1997;
- (b) \$\_\_ for a licence applied for in 1998;
- (c) \$\_\_ for a licence applied for in 1999; and
- (d) \$\_\_ for a licence applied for in or after 2000.

#### SIXTY-DAY LICENCE — NON-RESIDENT

5. The fee payable by a non-resident who is 18 years old or older for a sixty-day licence referred to in subsection 5(3) of the Act is \$\_\_.

#### LICENCE TO POSSESS FIREARMS — MINORS

6. (1) The fee payable by an individual who is less than 18 years old for a licence to possess firearms that are neither prohibited firearms nor restricted firearms is as follows:

- (a) \$\_\_ for a licence that is valid for a period of one year or less;
- (b) \$\_\_ for a licence that is valid for a period of more than one year and not more than two years; and
- (c) \$\_\_ for a licence that is valid for a period of more than two years.

(2) The fee payable under subsection (1) is waived for an individual who is eligible to hold a licence under subsection 8(2) of the Act.

#### REPLACEMENT LICENCES

7. (1) The fee payable by an individual for the replacement of a licence is as follows:

- (a) \$\_\_ for licences referred to in sections 2, 3 and 4;
- (b) \$\_\_ for licences referred to in section 5; and

(c) \$\_\_ for licences referred to in subsection 6(1).

(2) The fee payable under paragraph 7(1)(c) is waived for an individual who is eligible to hold a licence under subsection 8(2) of the Act.
